**Note:** SunTrust Mortgage defines "initial disclosures" as any disclosures required to be provided to applicants under state or federal law or by SunTrust Mortgage's Seller Guide prior to the loan closing date.

As a reminder, eSignatures are not eligible when a notary is required on the sales contract.
